ORDER

As per paper read (2), the Dean, College of Agriculture, Vellanikkara has placed a proposal before the 67th Board of Studies, Faculty of Agriculture, for allotting catalogue number for Doctoral research programme of Agricultural Extension Education as "Ext 699" and revising the catalogue number of Master's research programme as "Ext 599".

The Associate Professor & Head, Department of Agricultural Meteorology, College of Agriculture, Vellanikkara has also placed a proposal before the 68th meeting of Board of Studies of Faculty of Agriculture, for correcting the course code in the revised syllabus of the approved PG programme, for three M.Sc. (Agri.) Agricultural Meteorology courses.

Both the proposals were in accordance with the ICAR - BSMA recommendation 2022. As per paper read (1), the Academic Council resolved and approved the implementation of

Post Graduate Curricula and Syllabi for PG (Mastesr's and Doctoral Programme) Studies as per ICAR– BSMA recommendation-2022 and accordingly they were enacted in KAU w.e.f the academic year 2022 onwards.

As per provisions laid down vide (5), the Academic Council have the powers to make recommendations regarding post - graduate teaching, research and extension education.

The Academic Council as per paper read (4) has approved the proposal.
